ORNL FCU PAYS SPECIAL DIVIDEND TO MEMBERSHIP

PAID OFF AUTO LOANS FOR 10 MEMBERS!

The ORNL Federal Credit Union (ORNL FCU) Board of Directors approved a \$5 million special dividend to be shared across the membership. In October 2022, over 124,000 members received a special dividend that was paid based on the depth and breadth of their relationships and balances at ORNL FCU over the last 12 months. This was the fifth consecutive year a special dividend was issued to members and since 2018, ORNL FCU has returned over \$21 million in value to the membership.

Coinciding with the \$5 million special dividend announcement, ORNL FCU also revealed that 10 randomly-selected members had their auto loan balances paid off in full. In addition to paying off these auto loan balances, the Credit Union provided each of the winning members with a check to cover the estimated taxes they would owe on the value of their loan payoff. Since 2019, ORNL FCU has paid off loan balances for 24 members, totaling over \$400,000.

ORNL FCU SCHOLARSHIP PROGRAM TO UTK [2023-2024]



Applications are being accepted through the ORNL FCU Scholarship Program for the 2023-2024 school year. A minimum of three (3) scholarships are awarded each school year to deserving students/members that

excel in education and social merit: One (1) B.A. Candler Scholarship, one (1) John McKittrick Scholarship, and one (1) David Watkins Scholarship. The \$1,000 scholarships can be used for tuition, books, or other school-related expenses. Only members of ORNL FCU and members of their families who are enrolled or plan to enroll in the University of Tennessee at Knoxville and are pursuing a 4-year degree are eligible to compete for the scholarship.

INTERESTED IN APPLYING?

Members can find information about the scholarship and application process on our website at ornlfcu.com at the bottom of the Community page, under the About tab. New this year is an online application option, but members still have the option to download the application and submit by mail or email.

All applicants must also complete a FAFSA Form for federal student aid coded for the University of Tennessee. This form must be filed by February 1, 2023.

Applicants are selected by the UT General Scholarship Committee and will be notified directly by the University of Tennessee Financial Aid Office by early June.
